# Ag<sub>3</sub>PO<sub>4</sub> Enhanced TiO<sub>2</sub> for Visible Light Photocatalysis of 2-Chlorophenol in Wastewater

Abstract— Facile in-situ synthesis and characterization of stable Ag<sub>3</sub>PO<sub>4</sub>/TiO<sub>2</sub> nanoparticles and their effectiveness for visible light photocatalysis has been reported. The surface morphology, crystal structure and chemical properties of the photocatalyst were characterized by using UV-vis-NIR spectroscopy, FSEM, XRD, XPS, TEM and nitrogen physisorption. The synthesized nanoparticles were polycrystalline with calculated energy band gap in the range of 2.3-2.5 eV. Deposition of Ag<sub>3</sub>PO<sub>4</sub> over the surface of TiO<sub>2</sub> resulted in stability increase and a significant shift in the UV absorption spectrum towards visible region. The photocatalytic experiments were performed under 112 W visible light irradiation ( $\lambda > 400$  nm). The catalyst showed complete degradation of 15 mg/L 2-CP within 120 minutes while 92.5 % degradation of 25 mg/L 2-CP was achieved under optimized conditions. The study confirmed that Ag<sub>3</sub>PO<sub>4</sub> /TiO<sub>2</sub> has high potential for degradation of 2-CP from wastewater under visible-light irradiation.

*Keywords*— Ag<sub>3</sub>PO<sub>4</sub>/TiO<sub>2</sub> nanoparticles, 2-chlorophenol, visible light photocatalysis, wastewater.

## I. INTRODUCTION

Recently, application of heterogeneous photocatalysis as an advance oxidation process for eradication of toxic organics has been seen as a potent solution to wastewater contamination problems [1], [2].  $TiO_2$  has become the most extensively studied photocatalyst. However the large energy band gap (3.2 eV) limits its use only to ultraviolet (UV) light driven photocatalysis which comprises only about 4% of solar spectrum incident on earth. Such dependence makes TiO<sub>2</sub> unsuitable for use in visible light activated photocatalytic applications [3]-[8]. Current research focuses on development of modified photocatalysts able to harness the visible spectrum of light which comprises the larger portion ( $\sim 46\%$ ) of sunlight [9]-[11]. The strategies adopted to achieve such goal for instance may include creation of low energy impurity states within the  $TiO^2$  band gap through noble metal doping or codeposition that may promote formation of electron hole pairs [12]-[15]. Ag<sub>3</sub>PO<sub>4</sub> has been reported to effectively utilize visible light for water splitting and organic contaminants degradation [16]-[19]. A few studies suggest that Ag<sub>3</sub>PO<sub>4</sub> shows up to twelve times faster degradation of certain dyes compared to commercially available TiO2-xNx and BiVO4

with up to 90 % quantum efficiency upon exposure to light with wavelength over 420 nm [19],[20]. However the instability and photo-corrosion of  $Ag_3PO_4$  in aqueous medium has been associated with the loss in photocatalytic efficiency over time making catalyst recycling and reuse difficult [21],

[22]. Therefore, it is highly desirable to synthesize modified and stable photocatalysts that can effectively utilize the visible light harnessing power of Ag<sub>3</sub>PO<sub>4</sub> nanoparticles with minimal consumption of expensive Ag precursors. Recently a facile insitu preparation route for Ag<sub>3</sub>PO<sub>4</sub> nanoparticles deposition onto the TiO<sub>2</sub> (Degussa P25) surface has been reported to increase both the stability and photocatalytic activity of TiO<sub>2</sub> based photocatalysts [23]. This study reports in-situ precipitation method for the synthesis of Ag<sub>3</sub>PO<sub>4</sub>/TiO<sub>2</sub> nanoparticles and evaluates the effectiveness of synthesized nanomaterials for visible light photocatalysis of 2-CP as a model pollutant in water. The degradation pathways as a linear function of the concentrations of chlorophenol and catalyst have been considered for the interpretation of the kinetic data in this work. The choice of 2-CP was made due to the fact that phenol and its derivatives are commonly encountered organic pollutants in petrochemical, pharmaceutical and chemical industry wastewater causing severe environmental problems if not properly removed before discharge [24]. 2-CP among eleven phenolic compounds has been included in the priority pollutants list of United States Environmental Protection Agency (US EPA) and the European Union Water Framework Directive list of priority substances [25], [26]. Also the biological, physical, and physicochemical water treatments are often ineffective or environmentally incompatible for degradation of such organic contaminants [27].

#### **Experimental Materials**

Silver phosphate (Sigma-Aldrich); Degussa Titania (P25) (Sigma-Aldrich); Sodium phosphate; 2-Chlorophenol (2-CP) (Merck) standard grade was utilized as pollutant. De-ionized water was used for solution preparation. All other chemicals were of analytical grade.

#### Synthesis of Ag<sub>3</sub>PO<sub>4</sub>/TiO<sub>2</sub> photocatalyst

Synthesis of 0.3-molar ratio of silver phosphate doped onto Degussa Titania (P25) (Aldrich procured) was carried out using the in-situ precipitation method reported in literature [23]. Degussa P25 (0.02 mol) was dispersed in 50 ml distilled water and the solution was sonicated for 5 min. Silver nitrate (0.018 mol, Sigma-Aldrich) was then added to the sonicated P25 solution and the resulting solution magnetically stirred for 10 min at 250 rpm. Sodium phosphate (0.006 mole) was dispersed in 50 ml distilled water and was then added dropwise to the previously prepared solution. The final solution



was then magnetically stirred at 250 rpm for 5 h. A color change was observed from white to yellow. The resulting solution was then filtered, washed and dried in air overnight.

## **Material Characterization**

Characterization of the synthesized Ag<sub>3</sub>PO<sub>4</sub>/TiO<sub>2</sub> was performed by powder X-ray diffraction (XRD) measured with a Philips PANalytical Xpert PRO X-ray diffractometer using CuKa radiation (45 kV accelerating voltage and 20 mA applied current). The surface area was determined by the Brunauer-Emmett-Teller (BET) method using а Quantachrome Autosorb IQ. X-ray photoelectron spectroscopy (XPS); (PHI 5000 VersaProbe II). Transmission electron microscopy (TEM) was performed on a Morgagni Transmission Electron Microscope and the images were obtained at an accelerating voltage of 60 kV. Field emission scanning electron microscopy (FESEM) (JSM-7500 F; JEOL-Japan) using parallel beam geometry and a multi-purpose thin film attachment. Optical reflectance of the synthesized powder material was recorded by UV-vis-NIR spectrophotometer (PerkinElmer UV/Vis/NIR; Lambda 750) equipped with integrating sphere was used to record the diffuse reflectance spectra of the synthesized powder nanocomposite in the wavelength range of 200–900 nm. Kubelka–Munk (K–M) transformation was applied on the % R values to calculate the band gap of the synthesized Ag<sub>3</sub>PO<sub>4</sub>/TiO<sub>2</sub> nanoparticles by plotting  $(F(R) \times hv)^2$  and  $(F(R) \times hv)^{1/2}$  versus hv (eV).

#### **Photocatalytic Experiments**

Luzchem photochemical reactor (LZC4) system was used for evaluation of the visible light photocatalytic performance of Ag<sub>3</sub>PO<sub>4</sub>/TiO<sub>2</sub> in terms of 2-CP degradation. In a typical experiment fixed amount (0.5 to 1.5 g/L) of the photocatalyst was mixed with the 2-CP solution in a cylindrical rector cell (250 ml capacity) provided with air circulation to ensure aerobic conditions required for photocatalysis. Magnetic stirring was provided to ensure thorough mixing. The reaction contents were irradiated with visible light lamps from top and sides with spectral range from 400 to 700 nm and spectral irradiance of 17.45 mW/cm<sup>2</sup> monitored by Luzchem power monitor at a distance of 12 cm from the light source and a maximum of 180 min irradiation time. For analysis 2.5 ml samples were drawn after every 30 minutes and analyzed by using UV-visible spectrophotometer (HACH LANGE DR6000) at 274 nm. The 2-CP degradation efficiency was calculated, after analysis, using the following relation:

where  $C_o$  and  $C_t$  denote initial and residual concentration of 2-CP (mg/L) respectively and t denotes the irradiation time (min).

#### **Results and Discussion**

## Morphology, structural and optical properties of $Ag_3PO_4/TiO_2$

The X-ray diffraction (XRD) peaks corresponding to the body-centered cubic (bcc) phase of  $Ag_3PO_4$  are presented in **Fig. 1** for  $Ag_3PO_4/TiO_2$  composite. The diffraction peaks for  $Ag_3PO_4$  nanoparticles are represented in black font color at 2  $\theta$  values 21.8°, 29.6°, 33.5°, 36.7°, 48.2°, 55.0°, 57.5°, 60.9° and 72.1° corresponding to the diffractions from the (110), (200), (210), (211), (310), (222), (320), (321), and (332) crystal planes. Results shown exhibit crystalline integrity as reported in literature [23], [28] and the XRD peaks for Degussa P25 are easily distinguishable from the XRD patterns with representative (101), (004), (200), (211) and (002) crystalline planes represented in red font color.

The porosity and surface area of the photocatalyst were analyzed by  $N_2$  physiosorption using Quantachrome Autosorb IQ. After degassing the sample at a temperature of 200 °C for 180 min, nitrogen porosimetry was performed at a temperature of 77 K over the 0 to 1 pressure ratio. Results reported in Table I relate to the values available in literature [29].

The FSEM and TEM images of synthesized  $Ag_3PO_4/TiO_2$ nanoparticles are shown in **Fig. 2** (a) and (b) respectively. From the TEM image of the  $Ag_3PO_4/TiO_2$  composite, two distinct particles are identified. Larger particles with average particles size of 28-78 nm diameters represent TiO<sub>2</sub> Degussa P25 while the finer particles mainly deposited on the surface of TiO<sub>2</sub> in the range of 10-17 nm belong to  $Ag_3PO_4$ . The smaller size range of  $Ag_3PO_4$  nanoparticles can be attributed to the adsorption of silver ions onto the negatively charged surface of TiO<sub>2</sub> thus limiting the growth of  $Ag_3PO_4$ nanoparticles. Therefore the size of  $Ag_3PO_4$  in the composite structure can be controlled by using appropriate amount of  $AgNO_3$  Precursor.

The XPS survey analysis of the  $Ag_3PO_4/TiO_2$  shown in **Fig. 3**(a) confirms the presence of Ag, P, Ti and O as sample constituents. **Fig. 3**(b) shows the high resolution XPS spectrum of Ag 3d characterized by two peaks with binding energy values of 367.55 and 373.65 corresponding to the Ag  $3d_{5/2}$  and  $3d_{3/2}$ , respectively. Deconvolution of Ag 3d peaks resulted high intensity peaks at 367.72 and 373.73 eV representing Ag<sup>+</sup> and two low intensity peaks at 368.26 and 374.26 eV representing metallic silver Ag<sup>o</sup> in the Ag\_3PO\_4/TiO\_2 as reported by other studies [23], [28], [30].

The high resolution XPS spectrum of Ti 2p with  $2p_{3/2}$  peaks at 458.69 and 459.29 eV suggests the presence of TiO<sub>2</sub> (**Fig. 3**(c)). The O 1s peak was observed at 530 eV with a shoulder towards high binding energy value as shown in **Fig. 3** (d). On deconvolution three component peaks with different intensities were identified. The highest intensity peak with binding energy value of 529.78 eV belongs to the anionic O<sub>2</sub><sup>-</sup> from Ag<sub>3</sub>PO<sub>4</sub> and TiO<sub>2</sub> [31]. The shoulder peaks include peaks with 531.04 and 532.43 eV identified as Ag<sub>2</sub>O bound oxygen and oxygen from adsorbed H<sub>2</sub>O on the surface of TiO<sub>2</sub> [32]. Similarly, the peak at 133.15 eV (**Fig. 3**(e)) represents the P 2p core level peak characteristic of (PO<sub>4</sub>)<sup>3-</sup> group [33]. The XPS results suggest that in-situ deposition of (PO<sub>4</sub>)<sup>3-</sup> and Ag<sup>+</sup> ions on the surface of TiO<sub>2</sub> yielded stable precipitated Ag<sub>3</sub>PO<sub>4</sub>/TiO<sub>2</sub> composites.

The solid state absorption and diffuse reflectance spectra of the  $Ag_3PO_4/TiO_2$  showed two strong absorption edges around 420 and 520 nm corresponding to the absorption edges reported for TiO<sub>2</sub> (P25) and  $Ag_3PO_4$  respectively [34]. Kubelka–Munk transformation was applied to the UV reflectance data of the synthesized nanoparticles to calculate the values of F(R). The direct and indirect energy band gaps of the synthesized  $Ag_3PO_4/TiO_2$  nanoparticles were calculated by plotting  $(F(R) \times hv)^2$  (**Fig. 4** (a)) and  $(F(R) \times hv)^{1/2}$  (**Fig. 4** (b)) versus hv respectively. From the plot the band gap energy ( $E_g$ ) was determined by extrapolating the linear region of the plot on x-axis. The direct energy band gap of the synthesized nanoparticles was found to be at 2.52 eV while the indirect band gap was found to be 2.3 eV which is consistent with the values reported in literature for  $Ag_3PO_4$  [35]. These results suggest that  $Ag_3PO_4/TiO_2$  is an indirect band gap semiconductor.

#### **Photocatalysis**

Different factors affecting photocatalysis had been investigated. Solution pH is one of the main controlling factors that determine the photocatalytic degradation process. The solution pH values lower than point of zero charge of the photocatalyst material have been reported to facilitate hydroxyl radical and  $H_2O_2$  formation [36]. Fig. 5 shows the effect of solution pH on the Ag<sub>3</sub>PO<sub>4</sub>/TiO<sub>2</sub> catalyzed degradation of 2-CP. For 50 mg/L of initial 2-CP concentration and visible light irradiation for 180 min. Variation in solution pH values showed significant change in 2-CP degradation %. With the change in solution pH from 3, to 5 and 7; the corresponding values of 2-CP degradation varied from 70 %, to 55.68 % and 53.5 %. At pH values higher than 6 TiO<sub>2</sub> surface bears negative charge and existence of electrostatic repulsion between aqueous phenolate ions and TiO<sub>2</sub> may be responsible for lower adsorption rates and corresponding degradation efficiency. Higher pH values have also been reported to decrease the degradation rates due to OH<sup>-</sup> ions scavenging by thus formed carbonate ions [38]. The electrostatic binding of 2-CP at pH 3 facilitates adsorption of the pollutant onto the positively charged surface of Ag<sub>3</sub>PO<sub>4</sub>/TiO<sub>2</sub> that resulted in maximum degradation efficiency.

In a separate series of experiments 0.5-1.5 g/L of  $Ag_3PO_4/TiO_2$  was added to 50 mg/L 2-CP solution to evaluate the catalyst dose effect on photocatalytic degradation. As



shown in **Fig. 6**, an initial increase in catalyst dose from 0.5 to 1 g/L showed increase in degradation efficiency from 56% to 70.3% attributed to increased number of catalyst active sites with catalyst dose. However further increase in catalyst dose to 1.5 g/L showed decrease in degradation efficiency up to 41.4%. At high catalyst dose agglomeration and decreased penetration of light become significant thus responsible for the decreased photodegradation [38].

The photocatalytic performance of Ag<sub>3</sub>PO<sub>4</sub>/TiO<sub>2</sub> under optimized conditions was investigated over a wide initial pollutant concentration range from 15 to 50 mg/L (Fig. 7). Keeping the catalyst dose of 1g/L, 100 % degradation efficiency was observed when 15 mg/L of 2-Cp was exposed to visible light for 120 minutes. However further increase in 2-CP concentration to 25 and 50 mg/L resulted in decrease in degradation efficiency from 92.5% to 70.3% respectively for 180 min of irradiation time. This can be attributed to the decreased probability of 2-CP molecules to react with the active species on the surface of Ag<sub>3</sub>PO<sub>4</sub>/TiO<sub>2</sub> with increase in initial concentration. To evaluate the structural stability, the photocatalyst was recovered after use from the solution by decanting and centrifugation followed by washing with distilled water, filtration, and drying at 40°C for 180 min. The recovered catalyst was subjected to reuse for 3 runs with fresh 2-CP solution and it showed 100% visible light degradation efficiency for 15 mg/L of 2-CP as shown in Fig. 8.

### Conclusions

In-situ precipitation method was adopted to synthesize stable visible light active  $Ag_3PO_4/TiO_2$  nanoparticles photocatalyst. The photocatalytic activity of the synthesized catalyst was successfully tested for degradation of 2-CP under visible irradiation. The XRD and TEM studies confirmed the crystallinity and the nano size of the particles. The XPS analysis results confirmed the presence of Ag, P, O and Ti elements with their respective oxidation states corresponding to  $Ag_3PO_4/TiO_2$ . The synthesized catalysts showed high photoactivity with complete degradation of 15 mg/L 2-CP achieved at pH 3 within 120 minutes and 92.5 % degradation of 25 mg/L within 180 minutes of visible light irradiation.
