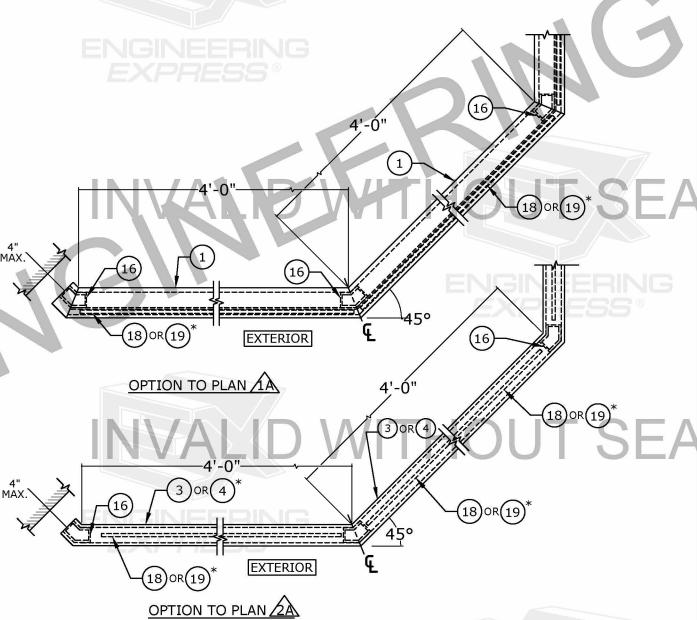


PLAN A: TYPICAL RAILING W/ EMBEDDED POSTS INTO CONCRETE SLAB W/ CENTERLINE GLASS
